<u>DHRC rule 6.3.3.15</u> — No horse claimed out of a claiming race shall be eligible to start in any race in the name or interest of the prior owner for 30 days, nor shall such horse remain in the same stable or under the care or management of the prior owner or trainer, or anyone connected therewith unless reclaimed out of another claiming race. Further such claimed horse shall only be eligible to enter in races in the State of Delaware for a period of 60 days following the date of the claim, unless released in writing by the DHRC Executive Director and Presiding Judge.

<u>DHRC rule 6.3.2.9</u> – If a horse is claimed, no right, title or interest therein shall be sold or transferred except in a claiming race for a period of thirty (30) days following the date of the claiming.

Declarations to race and entering in any other jurisdiction (including qualifying races) within 60 days of claiming a horse shall constitute a violation of DHRC rule 6.3.3.15.

Failure to comply with all aspects of this rule shall result in a major penalty.

This rule is in effect during dark times and after the racing meet ends.

CLAIMING REMINDERS

- 1. Claiming form should be filled out completely with the correct spelling of the horse's name.
- 2. Claims MUST be signed by all owners or an authorized agent. All authorized agents must be licensed as such with the DHRC.
- 3. An authorized agent must be an agent for ALL owners they sign for on the claim.
- 4. A trainer MUST be listed on the paperwork.
- 5. The person picking up the horse MUST be listed.
- 6. <u>DO NOT SIGN ANYONE ELSE'S NAME!</u> Sign your name only. If any signature on a claim form is found not to be authentic, the claim will be disallowed, and all persons associated with the claim may be subject to disciplinary action.
- 7. Claims must be turned in 30 minutes BEFORE the actual post time of the race (the post time that appears on the tote board NOT the scheduled post time or off time).
- 8. <u>Claimed horses</u> are only eligible to <u>enter</u> for races in the State of Delaware for a period of 60 days following the claim, unless released <u>in writing</u> by the DHRC Executive Director AND Presiding Judge.
- 9. No transfer of a claimed horse is allowed for 30 days. If you sell a claimed horse after 30 days, but before 60 days, please advise the new owner/trainer about the 60-day rule.
- 10. Claimant requested test results must be received from the analytical laboratory and show negative results before the horse may race again per DHRC Rule: 6.3.3.13. Turn-around-time can be as much as three weeks, which would result in the horse not racing for that time period.
